

**Bolts to Blocks:** From I-5 South take exit 234B From I-5 North take exit 235. Follow signs for Downtown Albany/Corvallis. You will enter downtown on Lyons Street. Continue on Lyons until reaching 1st Street, take a left on First. Continue on 1st for two blocks, take a left on Broadalbin. We are located on the corner of Second and Broadalbin.

**Chicks & a Rooster, 460 S Comstock Rd, Sutherlin, OR 97479; (541) 860-8140**

**From I-5 north or south,** take Exit 136 travel east, on Central .. turn right at log cabin onto Comstock. Travel about 3 blocks; Chicks & a Rooster is on left. .

**Country Lady, 611 SE Jackson, Roseburg; (541) 673-1007**

**Driving I-5** from the North or from the South, take Exit 124-City Center Exit. Go East on Harvard. If coming from the North, go through four stoplights. If coming from the South, go through three stoplights. At the first 4-way stop sign, Jackson Street, turn right; store is on the left hand side.

**The Fabric Farm, 438 West B Avenue, Drain; (541) 315-7171**

**From I-5 North,** take I-5 Exit 162 (Drain, Ocean beaches) and head West on Hwy 38 to Drain. Follow Hwy 38 through town & take a right at the stop sign towards Ocean Beaches. The Fabric Farm is on the Right past the light, just before Uncle John's Coffee, across from Deb's Diner. **FROM I-5 South** Take I-5 Exit 150 (Yoncalla) and head West. Go through Yoncalla to Drain & take a Left at the Stop sign (light). The Fabric Farm is on the Right, just before Uncle John's Coffee & across from Buddy's Diner.)

**Finally Together Quilt Shop, 54 West Ash St, Lebanon; (541) 258-6006**

**From I-5 north or south:** take Exit 228 toward Lebanon (heading East on Hwy 34). Travel 8 miles. Cross Railroad tracks, turn right on 2<sup>nd</sup> St. in front of Public Library. On 2<sup>nd</sup> to stop sign. Go 2 more blocks, turn left on Ash St. Shop is on right.

**Grandma's Attic Sewing Emporium, 167 SW Court St, Dallas; (503) 623-0451**

**From North on I-5** take Exit 260 (From S.: 253) marked Dallas/Ocean Beaches & follow on Rt 22 across the Marion Street Bridge in Salem. Continue on Rt 22 toward the Oregon Coast. Immediately after the intersection with 99W you will see a blinking yellow light. At the light, turn left toward Dallas. Drive into downtown Dallas. You will be on Main Street. When you see the Polk County Courthouse, get in the right lane so that you can turn right on Court Street. Come down 1/2 block. Grandma's Attic is on the left.

**From Hwy 99W** you will drive north from Junction City, Corvallis, & Monmouth. Pass through all these towns. The next little town will be Rickreall. Just past Rickreall, Hwy 99W intersects with Rte. 22. Turn left. Turn left at blinking yellow light. Drive into downtown Dallas. You will be on Main Street. When you see the Polk County Courthouse, get in the right lane so you can turn right on Court Street. Come down ½ block. Grandma's Attic is on the left.

**JanniLou Creations, 1243 Main, Philomath; (541) 929-3795**

**From I-5,** take Hwy 34 (Corvallis) exit #228 and travel west. Follow Hwy 34 approximately 11 miles. Just before crossing the bridge into Corvallis, there is a stop light. Turn left at the light (sign says to the coast) onto Hwy 20/34. Philomath is approximately 5 miles west of Corvallis. JLC is on the north side of Main Street (Highway) between 12<sup>th</sup> and 13<sup>th</sup> Streets. Note there is one way traffic on portions of Main & Applegate streets. **Be cautious of speed limits!** No fun getting tickets on Safari!!!!

**Piece By Piece, 62 W 13<sup>th</sup> St, Eugene; (541) 743-0266;**

**On I-5 coming from the north,** take Exit 194B for I-105/OR -126-W/OR-99N. Take the Jefferson St exit on the left toward the fairgrounds. Travel straight onto Jefferson St. Turn left on 13<sup>th</sup> Ave. Piece by Piece is on right side of 13<sup>th</sup> Ave between Olive and Willamette Streets. **Driving I-5 from the south, take Exit 192 for Franklin Blvd/OR-126-W/OR-99N.** Continue traveling west toward Eugene on Franklin Blvd. Make a slight left turn onto E. 11<sup>th</sup> Ave. Turn left onto Olive St. Left onto W. 13<sup>th</sup> Ave. Piece by Piece is on the right side of 13<sup>th</sup> Avenue between Olive & Willamette Streets.

**The Purple Frog Quilt Shop, 890 North 2<sup>nd</sup> Street, Jefferson; (541) 327-3764**

**From I-5 North or South,** take Exit 238 East 2 miles to stoplight. Continue .7 miles (this is 2<sup>nd</sup> St). Purple Frog is on the left.

**Quiltwork Patches, 212 SW 3<sup>rd</sup> Corvallis; (541) 752-4820**

**From I-5,** take the Corvallis/Lebanon exit (228). Head west on Hwy 34. Travel approximately 11 miles, cross the Willamette River into Corvallis. Turn left on 4<sup>th</sup>. Go 5 blocks to Jefferson. Turn left, go 1 block to 3<sup>rd</sup>. Turn left. Quiltwork Patches is on the left 3/4 down the block. Note: 3<sup>rd</sup> Street is Hwy 99 going north; 4<sup>th</sup> St. is Hwy 99 going South.

**Traveling North or South on I-5:** Take Exit 194A traveling East on Hwy 105/126. Take 3<sup>rd</sup> exit, 42<sup>nd</sup> Street, and turn right at the bottom of the ramp. Travel south on 42<sup>nd</sup> Street until you reach Main Street. It is a big intersection with an Arco, Taco Bell, Schuck's Auto Parts and McKenzie West Shopping Center on the corners. Travel through light and turn left into McKenzie West Shopping Center. We are located next to Deb's Restaurant.
